Eligibility

To qualify, you must:

- ✓ not have access to dental insurance
- ✓ be a Canadian resident for tax purposes
- ✓ have an adjusted family net income of less than \$90,000
- ✓ have filed your tax return in the previous year

The Canadian Dental Care Plan (CDCP) will help make the cost of dental care more affordable for up to **9 million** eligible Canadian residents.



How to Apply

CDCP Application Phases	
Group	Online applications open
Seniors aged 65 or older	Now
Adults with a valid Disability Tax Credit certificate	
Children under the age of 18	
All remaining eligible Canadian residents	May 2025: <ul style="list-style-type: none">• May 1: 55 to 64 years old• May 15: 18 to 34 years old• May 29: 35 to 54 years old

Oral health care is important to your overall health and well-being. Regular visits reduce the risk of health problems.

In 2022, 1 in 4 Canadians reported avoiding visiting an oral health professional due to the cost.

Renew your Canadian Dental Care Plan Coverage



Keep your Canadian Dental Care Plan (CDCP) coverage active by renewing **before June 1, 2025**

Who needs to renew

- Current CDCP members including those who applied **before** May 1, 2025

How to renew

Before renewing, you and your spouse or common-law partner (if applicable) must have:

- filed your 2024 tax return
- received your Notice of Assessment

You can renew:

- Online: **Canada.ca/dental** or **Canada.ca/MSCA** (your My Service Canada Account)
- By phone: 1-833-537-4342 or 1-833-677-6262 (teletypewriter)

You can renew for yourself and any dependents under 18 years of age.

If you don't renew,
your coverage will end
on **June 30, 2025**

You will have to pay for the services you receive after your coverage ends. You will not be reimbursed for these services if your coverage is renewed at a later date.
