- 4) Comparison of the Consulting vs Management Agreement was brought up on the shared screen. The management agreement became effective January 1, 2023. The chart will be attached to the minutes.
- 5) D. Carmichael presented information surrounding the Campus of Care status. Highlights were as follows:
- there is a potential to add additional beds at LLTC
- a site master plan of WPSHC property was conducted by architects out of Sudbury.
- WPSHC applied for 160 new beds through the Ministry. No information has been heard regarding this application.
- additional long term care beds are needed in West Parry Sound.
- -6) Status of municipal by-law return of the beds to the Ministry.
- D. Carmichael provided an update regarding municipalities returning the beds to the Ministry. Highlights were as follows:
- Belvedere Heights doesn't own the 101 beds, only manages on municipalities behalf.
- The Belvedere Heights Board met with municipalities in the summer of 2021, where all eight municipalities passed a by-law to surrender the 101 beds back to the Ministry.
- Nothing has been heard back from the Ministry.
- 7) An update was circulated with the agenda regarding an update and fact regarding Life Lease and will be attached to the minutes.

The offer was made by the Belvedere Board that if municipalities would like to meet with them, they are more that happy to do so.
