The Township of McKellar is reconstructing 3.1 kilometres of Centre Road and requires the existing road surface to be pulverized. The road section is located approximately 3.0 km from McKellar starting at the FR203 south 3.1 km to Lees Road.

Supplementary Specifications

General Description of Work (pulverizing)

The Contractor shall pulverize the road surface from approximate FR 203 to Lees Road. The existing surface is double surface treatment overlaid with a layer of Micro Surfacing. The surface is approximately 7.6 metres wide. The pulverizing includes 4 surface treated intersections, Lake Side Road, Bromley Road, Camp Road, and Lee's Road

The pulverizing and mixing of materials shall extend approximately 100mm - 150mm deep. The pulverized product shall produce a mixed material with 100% passing through a 50mm sieve and 95% passing a 37.5 mm sieve. OPSS MUNI 330 Clause 330.07.03. If the pulverized material is coarser than specified the Contractor shall repeat the pulverizing at the Contractor's expense.

The Contractor pulverizing the road shall be responsible for Traffic Control for their operations during pulverizing. The Township shall compact and grade the pulverized material.

The bidders shall visit the site to satisfy themselves of the scope of the work and contact Bob Hughes (RHH Engineering) regarding the details of the extent of the area to be pulverized.

Drawing SK-1 shows the approximate location of the area to be pulverized.

Payment

Payment for pulverizing shall be by the horizontal field measurement in square metres. OPSS 330.09.01.01.
