Recommendation:

That the Council of the Township of McKellar review and accept quotes from McPherson Andrews & Algonquin Bridge to replace the current Inholmes Bridge.

Background/Discussion:

The Inholmes Bridge was damaged on June 14, 2022 by Ambulance travelling at high speed. The Council of Township of McKellar previously approved \$200,000 for the construction of new bridge but total amount quoted by both companies are \$332,839 plus HST, which is higher than anticipated.

Budget Implication:

The cost of Inholmes Bridge construction will be funded through below sources:

- The \$125,000 will be used from Working Fund Reserve
- The \$25,0000 will be used from Infrastructure Asset Management Reserve
- The \$185,0000 will be used from Roads Vehicle Reserve
