- 1) This open, equal and fair rotational system would be another example of area collaboration and cooperation and not support the system that once IN always IN.
- 2) McKellar's contribution:
EMS: no rep = \$198,508
DSSAB: no rep = \$286,198 plus
Belvedere: 1 rep = \$103,207

AND WHEREAS the previous area EMS Advisory Committee has failed to inform McKellar of EMS meetings, agendas, minutes, issues or asked for our opinion, which was part of a previous understanding;

AND WHEREAS the Township of McKellar has been doing its part as a model of collaboration by informing other municipalities it represents of all Belvedere situations;

AND WHEREAS a representative from a new municipality will allow for new expertise and view going forward, which is healthy for any organization;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Township of McKellar hereby nominate Councillor Marco Ancinelli to the EMS Advisory Committee for the remainder of the current Term of Council and request support from the Township of Carling, the Municipality of McDougall and the Municipality of Whitestone.


