# **Expression of Interest (EOI) for Roadside Grass Cutting**

The Township of McKellar invites expressions of interest from qualified companies to provide roadside grass cutting on 220 lane kilometres along various municipal roads within the Township of McKellar (minimum of five (5) feet width per cut). This includes boat launch and parking areas.

## Scope of Work

The selected company will be responsible for:

- 1. The Expression of Interest is to provide roadside grass cutting on 220 lane kilometres, along various municipal roads within the Township of McKellar (minimum of five (5) feet width per cut). This includes boat launches and parking areas.
- 2. Areas with Milkweed must be left standing (there is no penalty for uncut areas). Work must be completed by the second-to-last Friday in July.
- 3. Clean equipment to prevent invasive species and plants. Before completing work for the Township of McKellar, the Public Works Superintendent or designate must inspect to ensure that the following general clean standard has been achieved on all equipment:
  - No clods of dirt should be visible after washing down.
  - Radiators, grills, and the interiors of vehicles should be free of accumulations of seed, soil, mud, and plant material parts, including seeds, roots, flowers, fruit, and stems.

#### Requirements

Interested companies must provide:

**Company Profile:** Background information, including years of experience in the commercial grass-cutting industry.

**Service Proposal:** Detailed description of the services offered, transportation methods, equipment size, mower size and processing capabilities.

**Pricing Structure:** A proposed pricing model for grass cutting hours is needed. Please also provide a schedule outlining when the grass-cutting will commence for the Municipal Office and other locations.

**References:** Contact information for at least three references from similar projects or clients.

### **Evaluation Criteria**

Submissions will be evaluated based on:

- Experience and expertise in roadside grass cutting.
- Ability to meet the Municipality's needs and service requirements.
- Competitive and fair pricing structure.

#### **Contract Duration**

The selected proponent will enter into an agreement with the Township that will be effective from the award date, and work will commence from June 30, 2025, to July 18, 2025.
