Group 3: Policies Vanessa, Leslie, Wanda, Leanne, Tony & Axy:

Presentation done at last meeting. Additional suggestions include look at existing bylaws, amendments if required, outcome of legal action regarding noise at a rental property (owner plead guilty, determined fines were consistent with infraction), simplify bylaws, ensure township website is up to date.

Read Axy's synopsis of the Oro Medonte decision

Maintain a guideline for future bylaw officers to share lessons learned (could be used in onboarding of future staff)

Creation of an educational product to summarize fire and noise bylaws

Simplify the bylaws with more detailed prohibitions based on time and place. Consider including decibel readings for stronger evidence in court

Make the bylaws easy to understand to assist with compliance.

Ensure bylaws number is easily located for complaints

New fire chief is reviewing bylaws: We should be consistent within the district. High means something different.

Mike Kekkonen: C2 zoning, owner operated, one site, regulated and reporting to oversight agencies. Highly regulated.

Bed and Breakfasts permitted at waterfront properties: Owners on site, permits given, not within eight hundred metres of each other.

Look at Tiny Township and use their resources. They have the budget and have put in the work; we should use their resources to our benefit.
